Kindly note that there are 5 pages in the form..

1. Filled in application forms to be submitted at the school gate between 16th to 20th February, 2022.
2. There will be a preliminary examination of the forms. All forms found incomplete/ with incorrect information will not be accepted.
3. **No enquiries will be entertained at the reception counter at the time of submission of forms.**
4. Name and Date of birth of the student and parents' names filled in the application form should be in complete accordance with the class X documentation. No alteration can be permitted at the time of admission and thereafter.
5. No alteration will be permitted in the application form once the same has been submitted. Hence you are strongly advised, if you so desire, that the necessary rectifications like addition/deletion of the name/surname/parent's name/s is done legally from the Issuing Authority **before** submission of the application form.
Kindly note the CBSE Rule : "Application regarding changes in name or surname may be considered, provided the changes have been admitted by the Court of Law and notified in the Govt. Gazette before the publication of the result of the candidate."
6. In case it comes to the knowledge of the management, at any point, that the information furnished is incorrect or wrong, the admission will stand cancelled without having any right to claim the refund of the fee paid.
7. The admission process will be considered complete only on completion of all formalities of admission and payment of fees within the stipulated time.
8. **Both parents must be present with the student on the day of admission** as the signatures of both are imperative.
9. Originals of all documents must be produced at the time of admission, to permit verification. In case, on verification, any document is found to be fabricated, forged or tampered with, the management reserves the right to cancel the admission.
10. Please note: The school does not take responsibility for providing transport facilities for the children. Parents are responsible for the same. However, there are a few private contractors plying buses for the school under an agreement with the school. Students may avail of this, seats permitting. Bus routes will not be changed to suit the individual's convenience. Parents are advised to take admission in schools near their residence. It will be the responsibility of the parent/guardian to drop and collect the child from the specified bus-stop.
11. The School being a minority institution reserves its Constitutional Right to give preference to children from the Christian Community. Preference may be given to Siblings, Wards of Alumni, Management and Wards of Staff . (As regards the wards of Alumni, preference will be given to those Alumni who have been active members of SJOBA and SJOBA Foundation for ideally of 5 years.and who have been supportive of the school.) Conditions apply.
Kindly Note : Preference does not guarantee admission.
12. Only ONE application form per student will be accepted. If it is found that more than one application has been submitted, all the applications submitted will stand cancelled.
13. Forms and all the accompanying documents/photographs, once submitted, will become the property of the school and **shall not be returned.**
14. In the eventuality that parents are unable to pay their son's fee, they will withdraw him from the school and will not seek a concession as the school already shoulders the expenses for the EDG children enrolled in the school.

IMPORTANT : Guidelines for parents and students for admission to Foreign Universities:

1. A student is required to submit the application format for LOR available with the class teacher at least one month prior to the last date of submission based on his academic and cocurricular performance.
2. Projected score will be based on
 - (i) Final Mark sheet of Class XI
 - (ii) Mid Term report of Class XII
 - (iii) Pre-Board 1 of Class XII
3. Grades in the certificate's will be strictly on the basis of assessment and merit.
4. Only in the event of a student missing an exam because he is representing the school, will a retest be given.
5. No request for marks other than those earned in the assessment will be entertained.
6. Projected scores will be strictly as per performance in the exams.
