- Kindly read the instructions carefully before you submit the application form:

 1. SC Judgement: The Hon'ble Supreme Court of India has held in the case of Society for Unaided Private Schools of Rajasthan v/s U.O.I. & Others Writ Petition (C) No.95 of 2010 that the provisions of the Right of Children to Free and Compulsory Education Act, 2009 (RTE) shall not apply to Unaided Minority Educational Institutions. The National Commission for Minority Educational Institutions, Government of India, New Delhi has declared St. John's High School, managed by the Congregation of Christian Brothers in India, to be a Minority Educational Institution within the meaning of Section 2(g) of the NCMEI Act. St. John's High School, Sector 26, Chandigarh, therefore, being a certified Christian Minority, Unaided Educational Institution, does not reserve 25% seats for the E.W.S.(Economically Weaker Section) as mandated in the Right of Children to Free and Compulsory Education, Act 2009. The school imparts education to the Christian community around and extends its service to the members of other communities to the extent possible communities to the extent possible.
- There are 5 printed pages in the form. Kindly ensure you have downloaded all the pages.

 Only those boys born between 1st April, 2020 and 31st March, 2021 will be eligible for KG admission for the academic year 2026-27. If your child is not within the age limit specified, he will <u>NOT</u> be considered for admission.

 There will be no screening of the children or their parents. Number of seats in UKG, in total = 160.
- Selection for free and open seats, if available after allocation of other seats, will be made by draw of lots on 17th January 2026 at the School premises at 10.00 a.m. Only a parent or an adult representative (ONE ONLY), CARRYING THE ACKNOWLEDGEMENT SLIP will be permitted to attend the draw of lots. Please do not bring children along.
- an adult representative (ONE ONLY), CARRYING THE ACKNOWLEDGEMENT SLIP will be permitted to attend the draw of lots. Please do not bring children along. Note: Children will not be allowed inside the School premises for the draw of lots.

 Finalization of selected candidates and waiting list will be displayed by 24th of January, 2026.

 Only filled-in application forms along with photocopies of relevant documents duly attested by a Gazetted Officer or by a 1st Class Magistrate or by an oath commissioner (the attestation must not be more than 6 months old) will be accepted between 09.00 am to 11:00 am from 9th December to 22nd December 2025 inclusive of both days (excluding holidays) at the School. No entry will be permitted for submission of forms after 11.00 am on 22nd December 2025 under any circumstances. No self-attested form will be accepted.

 Incomplete forms/those filled with incorrect information/unattested forms or forms without all the required documents, will NOT be considered for admission. The list of eligible candidates will be displayed on 14th January, 2026. No. queries will be entertained at the time of submission of forms.

 If the names and surragness given in the amplication form do not match with the birth certificate of the child and the identity proof of the parents, the amplication form will be considered.

- No enquiries will be entertained at the time of submission of forms.

 If the names and surnames given in the application form do not match with the birth certificate of the child and the identity proof of the parents, the application form will be considered thereofter in the School records. In case of sibling, the parent's names in the sibling's DOB incomplete and will NOT be considered for admission. No changes will be entertained thereafter in the School records. In case of sibling, the parent's names in the sibling's DOB certificate must exactly match the names on the applying child's Date of Birth Certificate. No spelling differences will be entertained.

- NB: The names of the parents and the child must also match the LKG School leaving certificate that will be submitted, in case of admission.

 No alteration will be permitted in the application form once the same has been submitted. Hence, you are strongly advised, if you so desire, that the necessary rectifications like addition/deletion of the name/surname/parent's name/s is got done legally from the Issuing Authority before submission of the Application Form.

 In case it comes to the knowledge of the School Management, on detailed verification of the documents submitted or at any point thereafter, that the information furnished is incorrect or wrong, or the documents submitted have been forged/fabricated/tampered with, the admission will stand cancelled forthwith, without any notice and without having any right to
- claim a refund of the fee paid. The School Management also reserves the right to initiate appropriate proceedings in case of any of the above contingencies.

 Submission of the Application Form and/or participation in the draw of lots does not guarantee admission. The admission process will be considered complete only on completion of all formalities of admission, verification of all documents and payment of fees within the stipulated time.
- Both parents must be present with the child on the day of admission, which will be a date after the draw of lots, as the signatures of both are imperative.

 Originals of all documents must be produced at the time of admission, to permit verification. In case, on verification or at any subsequent point of time, any document is found to be fabricated, forged or tampered with, the School Management reserves the right to cancel the admission forthwith.

 Please ensure that the acknowledgement slip that will be given to you is retained and produced whenever you come to the School regarding all future dealings pertaining to
- The School being a Minority Institution reserves its constitutional right to give preference to children from the Christian Community. Preference will also be given to Siblings, Wards of Alumni, Management and Wards of Staff. (Only wards of those Alumni, will be considered in the Alumni category who have studied in the school for a minimum period of ideally 5 years are members of the SJOBA Foundation as well as of SJOBA, have ideally been active for 5 years in SJOBA and who have been engaged with the School.) Conditions apply.

 Please note: In case the applications for these categories exceed the number of seats available, a draw of lots will be held within the various categories. You are, therefore, advised to apply in other schools as well as in the interest of your child's future.
- - Kindly Note: Preference does not guarantee admission. All alumni are requested to attach the documents mentioned as well as lists detailing how they have been engaged with SJOBA Foundation, SJOBA and St. John's High School.
- With the firm belief that children should not be exposed to the stress of long journeys, parents are advised to opt for neighbourhood schools.

 The school is not responsible for providing transport facilities. There are, however, a few private contractors plying buses which are being run on pre-designated routes. The routes on which the buses are plying are fixed by the private contractors and are available on the School website. Parents are therefore advised to apply to neighbourhood schools. Please note that parents will be responsible for arranging transportation for their child if no seat is available on the buses being run by the private contractors or the child stays outside the already designated routes. Please note: NO REQUESTS FOR NEW ROUTES/CHANGE IN ROUTES WILL BE ENTERTAINED by the School as the routes are fixed by the private
 - Please note: Parents using other means of transport, barring the buses run by the private contractors, will be responsible for making safe arrangements of transportation for their children. This includes verification of drivers of the vehicle and all other requirements as directed by the CCPCR, CBSE, Central Government and UT Administration, Hon'ble Punjab
- and Haryana High Court etc. Parents are, therefore, advised to take admission in schools near their residence.

 The School has already implemented numerous **safety and security measures** which are detailed on the School website http://www.stjohnschandigarh.com. Parents are requested to please go through the safety and security measures and apply only after they are satisfied with the measures in place. No objection to the measures adopted by the School will entertained once a child has been admitted into the School.

 Regarding School Rules: Parents are expected to strictly adhere to the rules in the interest of the discipline and safety and security of their children as well as the
- upbringing of a well-rounded human being. Timings must be strictly adhered to especially as regards the dropping and pick-up timings to/from the School, as per School Rules. Please note that at the time of admission and at all times thereafter, the medical details and record of the child shall be disclosed to the school keeping in mind the best interests and welfare of the child. Any previous medical history/or any other information pertaining to the child's physical, emotional and mental health must be disclosed.

 Please note: Parents are requested to disclose all information as they may be vital in case of an emergency and in the handling of your child. Parents will be expected to submit an undertaking to the effect that no medical issue is being withheld from the School.
- 22. Being a Christian Minority Educational Institution, who made a preferential option for the poor of society, the School has independently been educating children from the E.D.G.(Economically Disadvantaged Group) since 1996 and currently has nearly300students from this category fully integrated into the School. For the year 2026-27, the children from the E.D.G. have already been admitted as the School policy is to admit these children one year earlier at the preparatory level in order to bring them up to a standard that mits them to be fully integrated into the mainstream.
- Kindly Note: This is an entirely voluntary exercise as the School being a Christian Minority, Private, Unaided School does not come under the purview of the RTE Act in the matter. Only ONE application form per child is to be submitted. In the event of it being discovered that more than one application has been submitted for a child, all such forms will stand rejected and the candidate shall be disqualified and not be considered for the Draw of Lots.
- Parents to reach one hour prior in case of draw held in person.
- Forms and all the accompanying documents/photographs, once submitted, will become the property of the School and shall not be returned.
- At the time of submission of forms:

 - Kindly bring along an Original Date of Birth Certificate for verification purposes. The same will be returned immediately.

 There will be a preliminary examination of the forms. All forms found incomplete/with documents missing/unattested/with incorrect information will not be accepted.

 The accepted forms will, thereafter, be subjected to further detailed scrutiny after which the final list of eligible candidates for participation in the draw of lots will be prepared.
- The final list of eligible candidates for the draw of lots will be put up on 14th January, 2026 outside the School and on the School website.


